2. BOEING EMPLOYEES' CREDIT UNION referred to herein as "lender" is the owner and holder of the mortgage dated May 8, 2006 executed by LARRY W BOHALL and FRAN M BOHALL (which is recorded in volume 200605220267 records of SKAGIT County) under auditor's file no. concurrently herewith.)
3. LARRY W BOHALL and FRAN M BOHALL referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in Paragraph 2.

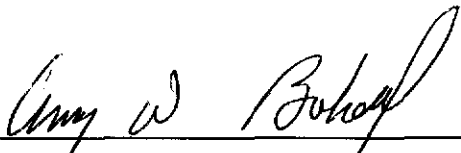

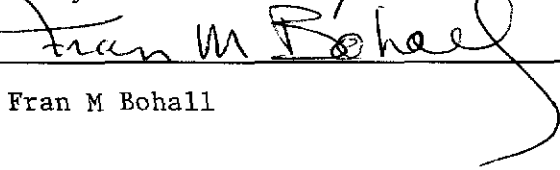

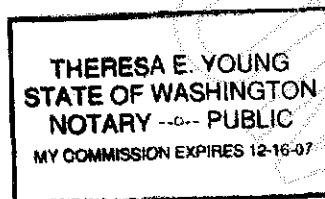
