## MEMORANDUM OF LEASE AND RIGHT OF FIRST REFUSAL TO LEASE

In consideration of One Dollar (\$1.00) and other valuable consideration paid by Tenant to Landlord and the mutual covenants contained in that certain Lease Agreement dated November 11, 2005, as amended by the First Amendment thereto (the "Lease"), Landlord has leased to Tenant, and Tenant has leased from Landlord, upon the terms and conditions set forth in the Lease, the real property located in the City of Anacortes, Skagit County, Washington, more particularly described in Exhibit A attached hereto and made a part hereof (the "Premises").
