PROCEDURE FOR MANUFACTURED / MOBILE HOME TITLE ELIMINATION

General.

The elimination of a title to a manufactured or mobile home is a process initiated most often by a lender during the loan process. Signing off on a Department of Licensing Title Elimination Form requires a building permit number and a department official's signature. The fee is \$25.00 regardless of the amount of research necessary to locate building permit records. Building permit fees shall be the current rate for Manufactured/Mobile homes, plus fees associated with any additional reviews.

Permit and Inspection Requirements.

- 1. Prior to February 13, 1968, no permit is required.
- 2. Prior to 1982, permit is required, no inspections required.
- 3. January I, 1982 current, permit and inspections required.

Permit Application Requirements.

Manufactured or Mobile Homes for which a permit was required but never issued requires the following:

- 1. Completed and signed building permit application.
- Completed site plan.
- Copy of old assessor records to verify date of placement/actual (verses effective), year of taxation.
- Septic Records. 4.
- Review of water source for quantity and quality depends on regulations at the time of placement (actual year of placement in 5. County Assessor records). Water quality/quantity Code effective January 1, 1992.
- Determine whether critical area review was required. Critical Area Ordinance effective June 13, 1996. 6.
- Determine whether school impact fees were required. School Impact Fee Ordinance effective June 1, 1997. 7.

Building permit fees shall be the current rate for Manufactured/Mobile homes, plus fees associated with any additional reviews.
