LEGAL DESCRIPTION

A leasehold interest in the following described property:

Tract 1 of the unrecorded Plat of "Raymond J. Paul Waterfront Tracts, Swinomish Reservation, Skagit Co., Washington", on file with the United States Department of the Interior, Bureau of Indian Affairs, Western Washington Indian Agency, Everett, Washington, and more particularly described as follows:

Beginning at the Northeast corner of Government Lot 3 of Section 34, Township 34 North, Range 2 East, W.M.;

thence South 89°42" West along the North line thereof, a distance of 20 feet to the Westerly line of the Pull N' Be Damned County Road;

thence South 2°31' East along the West line of said county road, a distance of 1,342.09 feet to the Southeast corner of Tract 50 of said "Raymond I. Paul Waterfront Tracts, Swinomish Reservation, Skagit Co., Washington;

thence South 89°42' West along the South line of said Tract 50 and Tract 50 produced, a distance of 291.48 feet to the Southeast corner of the tract herein described and the true point of beginning; thence North 4°54' West along the East line of Tract 1 of said "Raymond J.
