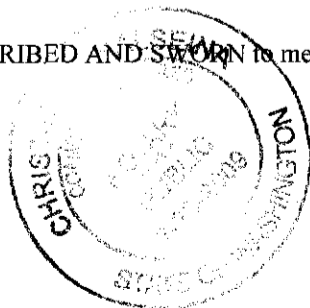

That portion of Lot 6 and Lot 7, Block 3, "MOORE'S ADDITION TO WOOLLEY", as per plat recorded in Volume 2 of Plats, page 62 records of Skagit County, Washington; and of the Southeast $\frac{1}{4}$ of the Northwest $\frac{1}{4}$ of Section 24, Township 35 North, Range 4 East, W.M., described as follows:

Beginning at a point on the South line of said Lot 7, which is 15.00 feet East of the Southwest corner thereof; thence South $87^{\circ}55'33''$ West along the South line of Lot 7, and Lot 6 a distance of 63.48 feet to a point which is 1.52 feet East of the Southwest corner of Lot 6; thence North $00^{\circ}38'36''$ East, a distance of 132.06 feet to North line of said Southeast $\frac{1}{4}$ of the Northwest $\frac{1}{4}$; thence North $88^{\circ}22'21''$ East long said North line, a distance of 89.68 feet; thence North $2^{\circ}04'14''$ East, a distance of 4.19 feet; thence South $65^{\circ}48'39''$ West, a distance of 41.20 feet; thence South $1^{\circ}40'55''$ East, a distance of 50.05 feet; thence South $88^{\circ}45'47''$ East, a distance of 6.06 feet; thence South $2^{\circ}04'14''$ East, a distance of 61.10 feet to the point of beginning.
