## DECLARATION OF COVENANT

I the undersigned, owner in fee simple of the land described herein, hereby declare this covenant and place same on record.

I the grantor herein, LANDMARK BUILDING & DEVELOPMENT, INC., am the owner in fee simple of (an interest in) the following described real estate situated in Skagit County, State of Washington; to wit:

on which the grantor owns and operates a well and waterworks supplying water for public use located on said real estate, at:

and grantor is required to keep the water supplied from said well free from impurities which might be injurious to the public health.

It is the purpose of these grants and covenants to prevent certain practices hereinafter enumerated in the use of said grantors water supply.

NOW, THEREFORE, the grantor agrees and covenants that said grantors, his heirs, successors and assigns will not construct, maintain, or allow to be constructed or maintained upon the said land of the grantors, any potential source of contamination, such as septic tanks and drainfields, sewerlines, underground storage tanks, roads, railroad tracks, vehicles, structures, barns, feed stations, grazing animals, enclosures for maintaining fowl or animal manure, liquid or dry chemical storage, herbicides, insecticides, hazardous waste, or garbage of any kind or description, within 100 (One Hundred) feet of the well herein described, so long as the same is operated to furnish water for public consumption.

These covenants shall run with the land and shall be binding to all parties having or acquiring any right, title, or interest in the land described herein or any part thereof, and shall inure to the benefit of each owner thereof.
