## AGREEMENT FOR CONSTRUCTION AND MAINTENANCE OF COMMON RETAINING WALL BETWEEN SUNSET COVE ESTATES LOTS #11 & #12

The retaining wall will establish and support the desired elevation changes between the properties and will be constructed on the property line between Sunset Cove Estates Lot #11 and Lot #12. By signature below, owners of both properties agree to share the initial expense to construct, and agree to maintain the retaining wall on the property line. Additional decorative and/or privacy walls will be the sole expense of individual property owners.

This agreement shall be effective this date and remain in full force and effect, and be binding upon the parties and their respective heirs, successors, and assigns including all subsequent owners of the properties. Subsequent changes to this agreement can only be made by written mutual agreement of both parties.
