LOAN MODIFICATION AGREEMENT TO THE DEED OF TRUST (LINE OF CREDIT TRUST DEED)

This Loan Modification Agreement (the "Agreement"), made this 2nd day of June, 2006 between MICHAEL O FAGERNES, (the "Borrowers") and Countrywide Bank, N.A., ("Lender") and Mortgage Electronic Registration Systems, Inc. ("Mortgagee") amends and supplements that certain DEED OF TRUST (LINE OF CREDIT TRUST DEED) dated May 03, 2006 and granted or assigned to Mortgage Electronic Registration Systems, Inc., as mortgagee of record (solely as nominee for Lender and lender's successors and assigns, P.O. Box 2026, Flint, Michigan 48501-2026) and recorded on May 10, 2006 as Instrument Number 20060500078 in the Official Records of the SKAGIT County, State of WASHINGTON (the "Security Instrument"), and covering the real property specifically described as follows:

In consideration of the mutual promises and agreements exchanged, the parties hereto agree to modify the Security Instrument as follows:

- TO COMPLETE SECTION I BY ADDING THE PRIOR DEED DATE OF "5-3-06", AMOUNT OF "\$459,960.00", AND LENDER "COUNTRYWIDE HOME LOANS" WHICH WAS OMITTED FROM THE RECORDED DOCUMENT AT THE TIME OF RECORDING
- TO ADD THE DECLARATION VERBIAGE OF "THE COVENANTS, CONDITIONS, AND RESTRICTIONS FILED OF RECORD THAT AFFECT THE PROPERTY," TO PAGE 2 OF THE PUD RIDER

The Borrowers shall comply with all other covenants, agreements and requirements of the Security Instrument. Nothing in this Agreement shall be understood or construed to be a satisfaction or release in whole or in part of the Security Instrument.

Except as otherwise specifically provided in this Agreement, the Security Instrument shall remain unchanged, and the Borrowers and Countrywide Bank, N.A. shall be bound by, and comply with all of the terms and provisions thereof, as amended by this Agreement, and the Security Instrument shall remain in full force and effect and shall continue to be a second lien on the above-described property. All capitalized terms not defined herein shall have the same meanings as set forth in the Security Instrument.
