AGREEMENT FOR FUTURE WATER SERVICE

THIS AGREEMENT FOR FUTURE WATER SERVICE ("Agreement") is entered into effect this day of October, 2006, by and between PUBLIC UTILITY DISTRICT NO. 1 OF SKAGIT COUNTY, a Municipal Corporation (hereinafter referred to as "District") and DANIEL H. MILLER and CAROL J. MILLER, husband and wife, their successors, heirs, and assigns (hereinafter referred to as "Owners"), owners of real property commonly known as Assessor's Parcel No. P36940 (19933 Cook Road, Burlington, Washington 98233), the legal description of which is as follows:

P36940

That portion of the East ½ of the Northeast ¼ of Section 20, Township 35 North, Range 4 East, W.M., described as follows:

Beginning at the Northeast corner of said subdivision;

THENCE West along the North line thereof, 882.75 feet;

THENCE South 1,083 feet, more or less, to the Northwest corner of a tract conveyed to C.E.

Megee by Deed recorded in Volume 186 of Deeds, page 365;

THENCE East 417 feet to the Northeast corner of said tract;

THENCE South 1,567 feet, more or less, to the South line of the Northeast 1/4;

THENCE East to the East section line;

THENCE North to the point of beginning,

EXCEPT roads.

Situated in County of Skagit, State of Washington.

WHEREAS, the District is installing an 18-inch waterline along Cook Road, and

WHEREAS, the Owners acknowledge granting a utility easement over a portion of their property known as Assessor's Parcel No. P36958 in exchange for monetary compensation in the amount of \$3,570.00, and


WHEREAS, the District has agreed to supply water to the property known as P36940.

NOW, THEREFORE, the District and Owners mutually agree that future water service to the subject property will be supplied according to the following terms and conditions of this Agreement:

- 1. The Owners, at the time of request for service, will pay the District the sum of (Three Thousand Five Hundred Seventy Dollars (\$3,570.00) for a Type 1 installation inclusive of System Development Fees on a one-inch meter.
- 2. This Agreement shall run with the land and shall bind any and all successors in interest. The District will record this Agreement in the official records of Skagit County, Washington. At the time that a water service connection is made to subject property and the water service fees paid, the District shall execute and record a cancellation of this Agreement.
