Dear Kristie,

This letter is being provided in order to assist you in the elimination of the title for the manufactured home referenced above.

Skagit County Code, 15.04, Section 3401, states "Buildings in existence at the time of the adoption of this code may have their existing use or occupancy continued if such use or occupancy existed prior to July 1, 1989 and provided such use or occupancy is not dangerous to life."

The above code section and statement means that since your home was placed prior to July 1, 1989, a building permit is not required for it to remain in its current location. The County considers the home to be legally placed by reason of date of placement. The County has no knowledge of, and offers no opinion concerning, the actual installation of the home in accordance with the manufacturers specifications or any existing decks or any other element of installation.
