MEMORANDUM OF MODIFICATION AGREEMENT Equity Line of Credit, Credit Limit Increase

This Memorandum of Modification Agreement (the "Memorandum") is recorded with reference to that certain deed of trust, mortgage or security deed, and any modifications or riders thereto dated March 13, 2006, executed by Sergey Kislyanka and Vera Kislyanka ("Borrower"), for the benefit of World Savings Bank, FSB ("Lender"), encumbering certain property located at 18807 Cascade Ridge Court, Mount Vernon, WA 98274 in the County of Skagit, State of Washington, more particularly described in Exhibit A attached hereto (the "Security Instrument"). The Security Instrument was recorded on March 22, 2006 in the official records as Instrument/Document No. 200603220027. The Security Instrument secures that certain Equity Line of Credit Agreement and Disclosure Statement of the same date and any renewals, extensions and modifications thereof, (including but not limited to, modifications increasing the Credit Limit) having a current Credit Limit of \$30,200.00 ("Note").

Borrower and Lender have entered into a Modification Agreement dated as of November 7, 2006 (the "Agreement"). The Agreement modifies certain terms of the Note and Security Instrument by increasing the Credit Limit provided for in the Note and Secured by the Security Instrument to \$80,200.00, and otherwise as more particularly contained in such Agreement. Except to the extent modified by the Agreement, all terms and conditions of the Note and Security Instrument remain unchanged and in full force and effect.


