That portion of the following described property that lays Southerly and Westerly of a line described as follows:

LINE DESCRIPTION:

Beginning at a point on the West line of the Southwest ¼ of the Southeast ¼ of Section 6, Township 35 North, Range 3 East, W.M., said point being the intersection of the Southerly line of Conner Slough and the Easterly side of West Ditch.

thence Southeasterly, in a straight line, to the point of intersection of the Easterly line of Conner Slough and the West line of Bayview Edison Road, and the terminus of this line description.

PARCEL A:

That portion of the Southwest ¼ of the Southeast ¼ of Section 6, lying North and East of the Conner Slough and lying Northerly of Dike District No. 5 ditch, which extends in a Westerly direction across said Southwest ¼ of the Southeast ¼ from the Northerly terminus of said Conner Slough; ALSO, that portion of Government Lot 2 lying North and East of the Conner Slough in Section 7, all in Township 35 North, Range 3 East, W.M. EXCEPT roads and ditch rights-of-way.
