

All that portion of the hereinafter described PARCEL "A" lying within a tract of land beginning at a point opposite Highway Engineer's Station (hereinafter referred to as HES) 588+15 on the SR 20 line survey of SR 20, Fredonia to Pulver Rd. Vic. and 185 feet southeasterly therefrom; thence southeasterly to a point opposite said HES 588+15 and 200 feet southeasterly therefrom; thence northeasterly parallel with said line survey to a point opposite HES 588+50 thereon; thence northwesterly to a point opposite said HES 588+50 and 185 feet southeasterly therefrom; thence southwesterly to the point of beginning.
