Commencing at the Southwest corner of the Southeast ¼ of the Southwest ¼ of said Section 2 from which the South Quarter corner bears South 89°36'00" East a distance of 1323.94 feet; thence South 89°36'00" East along the South line of the Southeast ¼ of the Southwest ¼ of said Section 2 a distance of 300.00 feet;

thence North 0°52'37" West, parallel to the West line of the Southeast ¼ of the Southwest ¼ of said Section 2, a distance of 311.50 feet to the Northeast corner of that certain tract of land conveyed to Kirk Wilson, et ux, by deed recorded May 18, 1972, under Auditor's File No. 768442:
