In addition, delinquent taxes are subject to penalties as follows: Three percent on the full year amount of tax unpaid on June 1<sup>st</sup> of the year in which tax is due. An additional penalty of eight percent on the amount of tax delinquent on December 1<sup>st</sup> of the year in which the tax is due.


