QUITCLAIM DEED

The GRANTOR, State of Washington, State Board for Community & Technical Colleges, acting through the Department of General Administration, for and in consideration of Ten Dollars (\$10.00), conveys and quitclaims to the GRANTEE, Overlook Waterfront, LLC, all interest in the following described real estate situated in the county of Skagit, State of Washington:

PARCEL A:

That portion of Government Lot 8 of Section 36, Township 34 North, Range 4 East of the Willamette Meridian, lying South of a line running East and West, 10 rods North of and parallel with the South line of said Lot 8, and lying Westerly of the Westerly right-of-way line of the Northern Pacific Railroad right-of-way;

EXCEPT road:

TOGETHER WITH all shore land of the 2<sup>nd</sup> class acquired from the State of Washington, in front of, adjacent to, or abutting upon the above described tract in Lot 8, Section 36, Township 36 North, Range 4 East of the Willamette Meridian, said shore lands being that acquired from the State of Washington under deed dated May 12, 1924 and recorded under Auditor's File No. 176360, records of Skagit County, Washington;

TOGETHER WITH that portion of the 100 foot wide railroad right-of-way, commonly known as the Northern Pacific Railway, in the Southeast Quarter of Section 36, Township 34 North, Range 4 East of the Willamette Meridian, which lies Westerly of the centerline of said right-of-way and between the Easterly extensions of both the North and South lines of the South 165 feet of said subdivision;

EXCEPT that portion thereof lying within the County road right-of-way established by that certain easement recorded April 10, 1979, under Auditor's File No. 7904100016, records of Skagit County, Washington.

Situated in Skagit County, Washington.

PARCEL B:

Tract B, WEST VIEW, REPLAT OF BLOCK 40, MONTBORNE, according to the plate thereof recorded in Volume 6 of Plats, page 5, records of Skagit County, Washington;

TOGETHER WITH that portion of the 100 foot wide railroad right-of-way commonly known as the Northern Pacific Railway (as originally conveyed to the Seattle Lake Shore and Eastern Railway), adjoining the Plat of West View, Replat of Block 40, Montborne, according to the plat thereof recorded in Volume 6 of Plats, page 5, records of Skagit County, Washington, that lies Westerly of the centerline of said right-of-way and between both the Easterly extension of the North line of Tract B and the Northeasterly extension of the centerline of an unnamed roadway lying between Lot 24 and Tract B of said plat;

EXCEPT that portion thereof, if any, lying within a county road right-of-way. Situated in Skagit County, Washington.

The Grantee, its successors or assigns, will protect, save and hold harmless the Grantor, its authorized agents and employees, from all claims, actions, costs, damages or expenses of any nature whatsoever arising out of or in connection with any acts or activities authorized by this Quitclaim Deed. The Grantee further agrees to defend the Grantor, its agents or employees, in any litigation, including the payment of any costs or attorneys' fees, for any claims or action commenced thereon arising out of or in connection with acts or activities authorized by this Quitclaim Deed. This obligation shall not include such claims, costs, damages, or expenses which may be caused by the sole negligence of the Grantor or its authorized agents or employees; Provided, that if the claims or damages are caused by or result from the concurrent negligence of (a) the Grantor, its agents or employees, and (b) the Grantee, its agents or employees and involves actions covered by RCW 4.24.115, this indemnity provision shall be valid and enforceable only to the extent of the negligence of the Grantee or Grantee's agents or employees.

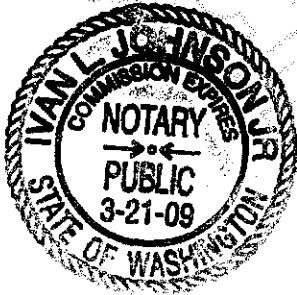

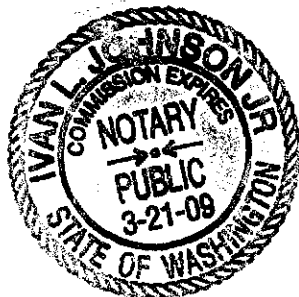
