person or persons legally entitled thereto, the Estate now held by Trustee under said Deed of Trust.




EXHIBIT "A"
LEGAL DESCRIPTION

Those portions of Government Lot 2, Section 4, Township 35 North, Range 4 East of the Willamette Meridian, described as follows:

1. Beginning at the intersection of the Northerly line of the County Road No. 279, as conveyed to Skagit County under Auditor's File Nos. 119472 and 272386, records of Skagit County, Washington, (formerly the Old Fairhaven and Southern Railway right-of-way) with the East line of said Government Lot 2;
Thence Northwesterly along said Northerly line 500 feet to the true point of beginning;
Thence Northerly at right angles to said road a distance of 164 feet;
Thence Northwesterly, parallel with the Northerly line of the County Road, 200 feet;
Thence Southwesterly 435 feet, more or less, to a point on the Northerly line of the County road which is 318 feet Easterly (as measured along said Northerly line) of its intersection with the West line of said Government Lot 2;
Thence Easterly along the Northerly line of the County road to the true point of beginning.

2. Beginning at a point on the Northerly line of the County Road No. 279 which is 268 feet Easterly of its intersection with the West line of said Government Lot 2 (as measured along the Northerly line of said road);
Thence Northerly at right angles to said road to a point which is 40 feet Northerly of the centerline thereof, said point being the true point of beginning of this description;
Thence continue along said line 8 feet;
Thence Easterly parallel with the North line of said road 8 feet;
Thence Southerly at right angles to said road 8 feet;
Thence Westerly 8 feet to the true point of beginning (it being the intent of this description to describe the area within which an existing well is now located).
