

PARCEL "A"

That portion of Tract "A" of Skagit County Short Plat No. 70-77, approved October 6, 1977 and recorded October 6, 1977 as Auditor's File No. 866231 in volume 2 of Short Plats, Page 136, records of Skagit County, Washington, described as follows:

Begin at the Southwesterly corner of Tract "B" of said short plat, thence South 7 deg. 08' 25" East along the fenceline delineating the West line of Tract "A" a distance of 30 feet; thence North 74 deg. 48' 49" East parallel with the Southerly line of said Tract "B", a distance of 67 feet; thence North 7 deg. 08' 25" West parallel with the West line of said Tract "A" a distance of 30 feet to a point on the Southerly line of said Tract "B"; thence South 74 deg. 48' 49" West along said Southerly line a distance of 67 feet to the point of beginning.

PARCEL "B"

Tract "B" of Skagit County Short Plat No. 70-77, approved October 6, 1977 and recorded October 6, 1977 as Auditor's File No. 866231 in Volume 2 of Short Plats, Page 136 records of Skagit County, Washington.

Both of the above described Parcels "A" & "B" being a portion of the Northeast quarter of the Northwest quarter in Section 19, Township 35 North, Range 5 East W.M.

The above described Parcel "A" will be combined or aggregated with the contiguous Parcel "B" owned by the grantees. This boundary adjustment is not for the purpose of creating an additional building lot.
