DECLARATION OF COVENANT

I (we) the undersigned, owner(s) in fee simple of the land described herein hereby declare this covenant and place same on record.

I (we) the grantor(s) herein, am (are) the owner(s) in fee simple of (an interest in) the following described real estate situated in Skagit County, State of Washington; to wit:

Parcel located in the SW 1/4 of NE 1/4 of Section 10, Township 35 North, Range 4 East.

On which the grantor(s) owns and operates a well and waterworks supplying water for public use located on said real estate, at:

BEGINNING AT THE CENTER OF SECTION OF SAID SECTION 10, TOWNSHIP 35 NORTH, RANGE 4 EAST, W.M., SKAGIT COUNTY, WA; THENCE SOUTH 89º58'56" EAST 941.36 FEET, THENCE NORTH 00º01'04" EAST 172.56 FEET TO THE WELL HEAD LOCATION SITUATED IN SKAGIT COUNTY, WASHINGTON.

And grantor is required to keep the water supplied from said well free from impurities which might be injurious to the public health.

It is the purpose of these grants and covenants to prevent certain practices hereinafter enumerated in the use of said grantor(s) water supply.

NOW, THEREFORE, the grantor(s) agrees(s) and covenant(s) that said grantor(s), his (her) (their) heirs, successors and assigns will not construct maintain, or suffer to be constructed or maintained upon the said land of the grantor(s) and within 100 (One Hundred) feet of the well herein described, so long as the same is operated to furnish water for public consumption, any potential source of contamination, such as septic tanks and drain fields, sewer lines, underground storage tanks, roads, railroad tracks, vehicles, structures, barns, feed stations, grazing animals, enclosures for maintaining fowl or animal manure; liquid or dry chemical storage, herbicides, insecticides, hazardous waste, or garbage of any kind or description.

These covenants shall run with the land and shall be binding to all parties having or acquiring any right, title, or interest in the land described herein or any part thereof, and shall inure to the benefit of each owner thereof.
