DECLARATION OF CANCELLATION OF PARTIAL RECONVEYANCE AND
REINSTATEMENT OF DEED OF TRUST *W1060006*

Whereas, on 12/05/2006, the undersigned Trustee Services, Inc. was the successor trustee of all of the following described real property: TAX ID NUMBER: 340409-3-015-0800/P125058

ACREAGE ACCOUNT, ACRES 0.34, LOT 3 OF MOUNT VERNON SHORT PLAT LU-04-091 RECORDED AF#200609210114, BEING A PORTION OF TRACT 3 OF MOUNT VERNON SHORT PLAT MV-1-79, BEING A PORTION OF THE SW1/4 OF THE SW1/4.

And as particularly described in that certain Deed of Trust dated 09/27/2006, executed by WPC JOINT VENTURE LLC, as Grantor, to LAND TITLE COMPANY, as Trustee, in favor of BUSINESS BANK OF SKAGIT COUNTY, to secure an indebtedness of \$277,500.00, and recorded on 9/29/2006 under Auditor's File Number 200609290137, records of SKAGIT County, Washington; and

Whereas, on 12/05/2006 there was recorded in the Office of the County Auditor of Skagit County, Washington, a Partial Reconveyance, Auditor's File Number 200612050028 executed by the Trustee under said Deed of Trust, purporting to reconvey from the force and effect of said Deed of Trust the above described real property; and


Whereas, said Partial Reconveyance was recorded through error, inadvertence, and mistake which recording was wholly contrary to the contemplation and intention of the parties to said Deed of Trust; and

Whereas, it is now the desire and intent of the parties to correct the record title of the land covered by said above referenced Deed of Trust by causing said Deed of Trust to be reinstated as a valid lien upon the hereinabove described real property.

Therefore, Trustee Services, Inc., the undersigned, in consideration of the premises herein recited, does declare that certain Partial Reconveyance recorded on 12/05/2006 under Auditor's File Number 200612050028 records of Skagit County, Washington, is null and void, and of no force and effect and that the lien of that certain Deed of Trust recorded under Auditor's File Number 200609290137, records of Skagit County, Washington, is hereby declared to be reinstated as a lien upon the above described property, with full force and effect and priority, as of the original date of execution of said Deed of Trust, to the same effect as though the Partial Reconveyance recorded under Auditor's File Number 200612050028 records of Skagit County, Washington had never been issued and recorded.


