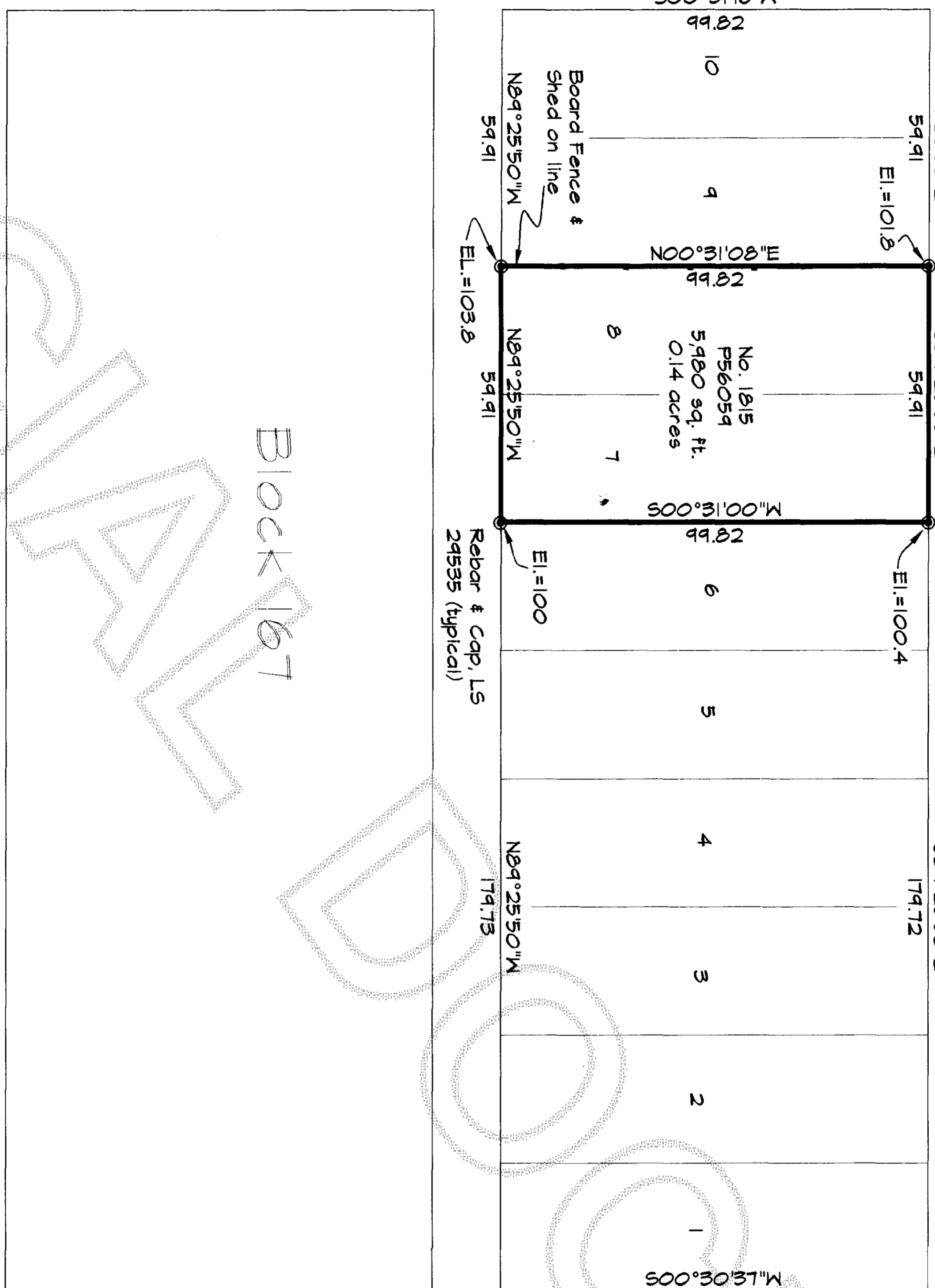

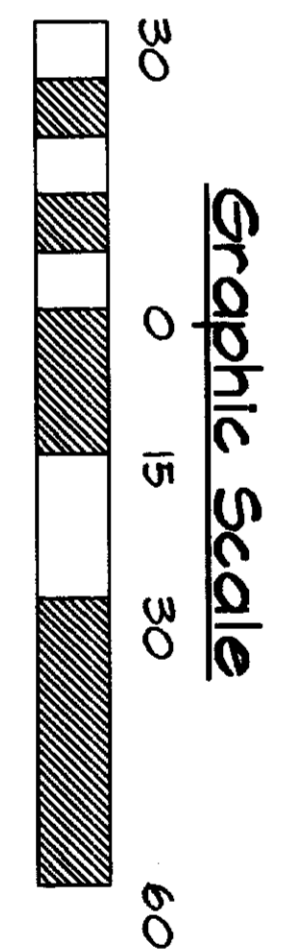


**Survey Notes**

The purpose of this survey has been to locate, describe and to set monuments to mark the existing lines and corners of the above described property.

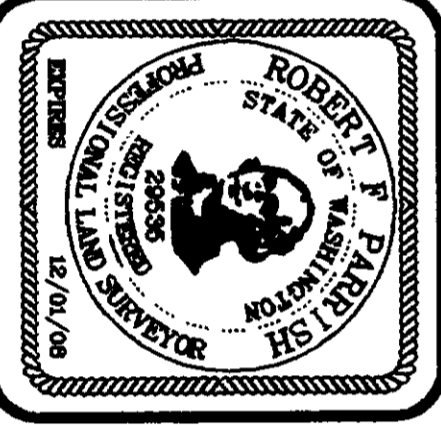
Vertical Datum Elevations are relative to this site, displayed on corner monuments. The anticipated positional tolerance of elevations is ±0.10'.

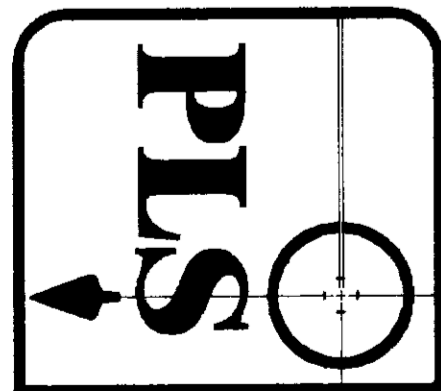
