## EXTINGUISHMENT OF EASEMENT

THIS AGREEMENT is executed this 2 Nd day of March, 2007, by and between Bradley R. Paulson and Marjorie A. Paulson, husband and wife, hereinafter "Paulson", and the City of Anacortes, hereinafter the "City", for the purpose of extinguishing a portion of two utilities easements held by the City. This Agreement is based upon the following circumstances:

## RECITALS:

- A. The City, by Ordinance No. 684, vacated B Avenue in the City of Anacortes lying between the north line of 11<sup>th</sup> Street and the inner harbor line, excepting the right-of-way of the Great Northern Railway Company, hereinafter the "Vacation Ordinance".
- B. The City reserved in the Vacation Ordinance the right to construct sewers within vacated B Avenue.
- C. By instrument entitled Easement for Utility Lines and Appurtenances, recorded under Skagit County Auditor's File No. 636193, the City acquired an easement over vacated B Avenue for utility purposes, hereinafter "Utility Easement".
- D. Paulson owns the real property lying east and adjacent to vacated B Avenue, more particularly described in attached Exhibit "A", hereinafter "Paulson Property". Paulson has requested that the City release and extinguish its easements over and across the east 15' of vacated B Avenue, lying between the north line of 11<sup>th</sup> Street and the inner harbor line, excepting the right-of-way of the Great Northern Railway Company, hereinafter the "Extinguishment Area".

E. The City has agreed to extinguish and release its easements and other rights to install utilities within the Extinguishment Area in exchange for the payment of Twenty Two Thousand Eight Hundred Fifty Two and 80/100 Dollars (\$22,852.80).

NOW, THEREFORE, in consideration of the mutual promises and agreements contained herein, the parties agree as follows:

- 1. Upon recording of this instrument, Paulson shall pay to the City Twenty Two Thousand Eight Hundred Fifty Two and 80/100 Dollars (\$22,852.80).
- 2. The City hereby relinquishes all rights and extinguishes any easements or other interest in real property held by the City within the Extinguishment Area.
- 3 Paulson and future owners of the Paulson Property shall have the right to use the

Extinguishment Area for the construction of stru	actures and other improvements.
