DRAINFIELD EASEMENT

We the undersigned, STEVE THEIN and KIM THEIN, declare that we are the owners of the following described real property:

Parcel Number P15569, that portion of the Southwest ¼ of the Northwest ¼, described as follows:

Beginning at a point on the North line of said subdivision 375.2 feet East of the Northwest corner thereof, said point being on the Easterly line of the County road; thence following said road South 39°35' East 190.7 feet; thence South 24°46' East 151.8 feet; thence South 8°14' West, 134.1 feet; thence North 89°56' East 417.4 feet; thence North 0°24' East 417.4 feet, more or less, to the North line of said Southwest ¼ of the Northwest ¼; thence South 89°56' West 583.5 feet along the North line of said Southwest ¼ of the Northwest ¼ to the point of beginning. All in Section 9, Township 33 North, Range 3 East, W.M. Situate in the County of Skagit, State of Washington; a.k.a. 19233 Landing Road, Mount Vernon, WA 98273.

As property owners, we declare that there exists a septic system drainfield on the southwestern portion of the property beginning approximately 35 feet from Landing Road and extending from approximately 10 feet north of the southerly property line for a distance of approximately 45 feet and east approximately 10 feet.

We also acknowledge that there exists a 10 foot buffer zone on each side of the drainfield and that we will refrain from building on the drainfield or in the buffer zone.

We declare that this easement is for the benefit of John and Gail Their and is not transferable and that if the drainfield fails, we are not responsible for repairing it.
