THIS AGREEMENT, made and entered into this 27<sup>th</sup> day of February, 2007, by and between LONGVIEW FIBRE COMPANY, a Washington Corporation, herein called "Grantor," and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein called "State," WITNESSETH:

**RECITALS**

- A. Whereas, on the 16<sup>th</sup> day of January, 2004, Grantor and State entered into an easement, hereinafter "Original Easement", which was recorded in the records of Skagit County, Washington on the 30<sup>th</sup> day of January, 2004, under Auditor's File No. 200401300177, and;
- B. Whereas on February 17, 2006, Grantor and State entered into an easement supplement to the Original Easement, herein called "Original Supplement #1", which was recorded in the records of Skagit County, Washington on March 1<sup>st</sup>, 2006, under Auditors File No. 200603010016,

and in the records of Whatcom County, Washington on March 1<sup>st</sup>, 2006, under Auditors File No. 200603010011, and;

- C. Whereas the State and Grantor wish to amend Original Supplement #1 to reflect the precise legal description.

Now, therefore, State and Grantor agree to amend Exhibit B of Original Supplement #1 as follows:

### **AGREEMENTS**

1. Exhibit B, Grantor's Burdened Parcels, shall be amended to include:  
NE1/4NE1/4 of Section 8, Township 36 North, Range 5 East.
2. Exhibit B, Grantor's Burdened Parcels, within the Original Supplement #1 shall be replaced with "Exhibit B" of this agreement.

Except as herein amended, all of the terms, conditions and reservations of the Original Easement and Original Supplement #1 shall remain in full force and effect.

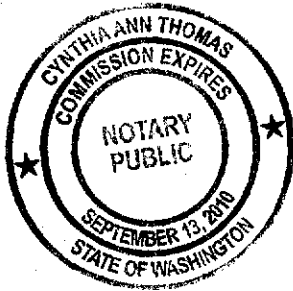

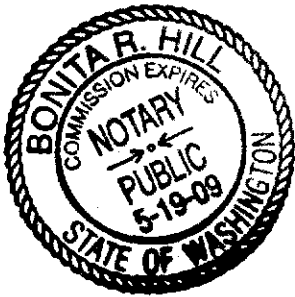
