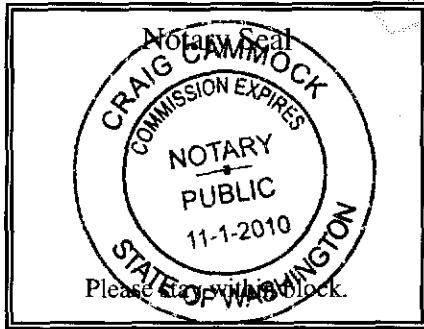

WARRANTY DEED

EXHIBIT A

That portion of Government Lot 1 of Section 5, Township 34 North, Range 2 East, W.M., in Skagit County, Washington, lying northerly of the northerly right-of-way line of SR 20 as shown on the right-of-way map titled SR 20, Jct. SSH No. 1-D to Swinomish Slough, Sheet 1 and 2 of 8 sheets, dated August 2, 1960, filed in the office of the Washington State Department of Transportation in Olympia, Washington;
EXCEPT the easterly 30 feet of said Government Lot 1;

ALSO EXCEPT that portion, if any, lying within the following described tract:

Beginning at the northeast corner of the northeast quarter of said Section 5; thence South 00°30'00" West along the east line of said northeast quarter, 2,376.15 feet; thence North 89°59'00' West, 1,241.83 feet to the True Point of Beginning; thence North 00°01'00" East, 150 feet; thence North 89°50'00" West, 200 feet; thence South 00°01'00" West, 150 feet; thence South 89°59'00" East, 200 feet to the True Point of Beginning;

ALSO EXCEPT that portion thereof, if any, conveyed to Skagit County by document recorded March 31, 1939 as Auditor's File No. 311441.

The Grantor herein reserves unto herself, her heirs, successors and assigns, for the benefit of Coachman Inns of America, Inc. a non-exclusive easement for the Coachman Inns' one-sided billboard sign, over and across that portion of said premises described as follows:

Beginning at a point opposite Highway Engineer's Station (hereinafter referred to as HES) 406+80 on the SR 20 line survey as shown on Skagit County Sundry Site Plans, Fidalgo Bay Wetlands Mitigation Area, and 110 feet northerly therefrom; thence northerly to a point opposite said HES 406+80 and 150 feet northerly therefrom; thence easterly to a point opposite HES 407+20 on said line survey and 150 feet northerly therefrom; thence southerly to a point opposite said HES 407+20 and 110 feet northerly therefrom; thence westerly to the point of beginning.

Said easement reserved herein will extinguish and terminate upon the earlier of (i) expiration or termination of Outdoor Advertising Sign Permit for the Coachman Inns' billboard sign, or (ii) removal or demolition of said billboard sign, or (iii) termination of the unrecorded Sign – Site Lease Agreement executed January 21, 2005 and February 9, 2005, respectively, between grantor and Lessee, Coachman Inns and any amendments thereto, or (iv) December 31, 2027. The Grantor herein agrees to execute and record a Quitclaim Deed terminating said reserved easement without cost to the Grantee.

Also, the Grantor herein conveys and grants to the State of Washington all rights of ingress and egress (including all existing, future or potential easements of access, light, view and air) to and from SR 20, Jct. SSH No. 1-D to Swinomish Slough; **EXCEPT** that the State shall construct on its right of way an **OFF** and **ON APPROACH**, not to exceed 14 feet in width, for access to the Coachman Inns of America Inc.'s billboard sign, on the northerly side of SR 20, at or near Highway Engineer's Station 126+60, as shown on Sheet 2 of 8 Sheets of the hereinafter mentioned SR 20 map of definite location, and to which **OFF** and **ON APPROACH** only, Coachman Inns of America, Inc., reserves a right of reasonable access. Said approach is to be used to serve more than one owner and/or utility. Coachman Inns' use of the approach expires pursuant to terms set forth in the easement reserved herein. The State will maintain said access approach.

The specific details concerning all of which are to be found in those certain maps of definite location now of record and on file in the office of the Secretary of Transportation at Olympia, and bearing date of approval July 13, 2006, revised March 14, 2007 for the Sundry Site Plan, and bearing date of approval August 2, 1960, revised March 14, 2007 for the SR 20 plan.
