## DECLARATION EXTINGUISHING EASEMENT AND CONFIRMING ABSENCE OF ALTERNATIVE EMERGENCY ACCESS PLAN

This Declaration Extinguishing Easement and Confirming Absence of Alternative Emergency Access Plan is made as of April 18, 2007, by the City of Anacortes, Washington, a municipal corporation ("Declarant").

Grantee is owner of all the real property described in that certain City of Anacortes Short Plat No. 91-005, approved October 24, 1991, recorded November 4, 1991, in Book 10 of Short Plats, pages 24 and 25, under Auditor's File No. 9111040088 and being a portion of the Southeast quarter of the Southeast quarter of Section 24, Township 35 North, Range 1, East, W.M., situate in the City of Anacortes, County of Skagit, State of Washington (the "Property").

Declarant is the beneficiary of a sewer easement described in instrument dated July 9, 1954. recorded under Auditor's File No. 519591, over and across a strip of land sixteen feet (16') in width, which land is now owned by Grantee Hyattcenters-Anacortes, LLC, comprised of lands now known as Skagit County Short Plat AN 91-005 (the "sewer easement").

Creation of Short Plat AN 91-005, recorded under Auditor's File No. 9111040088, included within it creation of "An easement as shown for ingress and egress and utilities and

emergency vehicle access. 30' easement shall never be blocked unless alternative emergency vehicle access plan is approved by the City of Anacortes." (The "Emergency Access Plan").
