THIS INDENTURE, made this 10th day of May, 2007, between Rick Grimstead, as Sheriff of the County of Skagit, State of Washington, party of the first part, and David C. Carpenter and Jackie L. Carpenter, parties of the second part,

WITNESSETH, That whereas, under and by virtue of a certain Amended Writ of Execution on Order of Sale issued out of the Superior Court of the State of Washington, for the county of Skagit, on the 19th day of July, 2006, in that certain cause entitled BENEFICIAL WASHINGTON, d/b/a BENEFICIAL MORTGAGE CO. OF WASHINGTON, plaintiff, against STEVE A. RAY and THE ESTATE OF DEBRA L. RAY, aka DEBBY L. RAY, aka DEBBIE L. RAY, aka Dibbie L. Ray, her Heirs and Devisees; PAUL F. 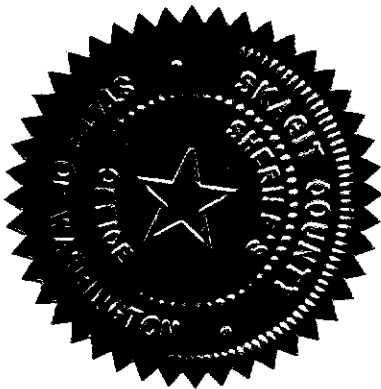



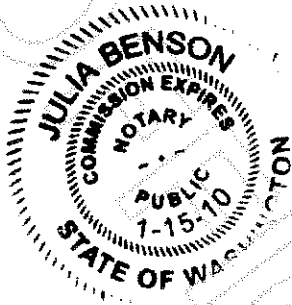
