


EXHIBIT A

All that portion of the hereinafter described PARCEL "A" lying northwesterly of a line beginning at a point opposite Highway Engineer's Station (hereinafter referred to as HES) 315+80 on the SR 20 line survey of SR 20, S. Campbell Lake Rd. to Gibralter Rd. Vic. and 55 feet southeasterly therefrom; thence northeasterly parallel with said SR 20 line survey to a point opposite HES 320+65 thereon; thence southeasterly to a point opposite said HES 320+65 thereon and 90 feet southeasterly therefrom; thence northeasterly parallel with said SR 20 line survey to a point opposite HES 327+10 thereon; thence northeasterly to a point opposite HES 331+20 on said line survey and 35 feet southeasterly therefrom and the end of this line description.

PARCEL "A"

That portion of the southwest quarter of the northwest quarter of Section 8, Township 34 North, Range 2 East, W.M., in Skagit County, Washington, lying southeasterly of the State Highway, EXCEPT the east 330 feet thereof.
