
EXHIBIT A

All that portion of the hereinafter described PARCEL "A" beginning at a point opposite Highway Engineer's Station (hereinafter referred to as HES) 318+30 on the SR 20 line survey of SR 20, S. Campbell Lake Rd. to Gibralter Rd. Vic. and 55 feet southeasterly therefrom; thence northeasterly parallel with said SR 20 line survey to a point opposite HES 318+90 thereon; thence southeasterly to a point opposite said HES 318+90 thereon and 90 feet southeasterly therefrom; thence southwesterly parallel with said SR 20 line survey to a point opposite HES 318+30 thereon; thence northwesterly to the point of beginning.

PARCEL "A"

That portion of the southwest quarter of the northwest quarter of Section 8, Township 34 North, Range 2 East, W.M., in Skagit County, Washington, lying southeasterly of the State Highway, EXCEPT the east 330 feet thereof.
