Grantor(s), hereby acknowledge that Grantee(s) completed construction of a generator shed and fixtures on Grantor(s) said real estate, within a fifteen-foot by fifteen-foot wide easement in accordance with said Restrictive Covenant And Well Agreement and Exhibit "A" of said agreement. acknowledge that Grantee(s) shall remove said generator shed and all fixtures as described in said **Restrictive Covenant And Well Agreement** within 60 (sixty) days from the date of recording this agreement in Skagit County Auditors Office. Said removal of all fixtures shall include, but not be limited to removal of the shed, all electrical equipment, generators, fuel systems, concrete slab and all underground wiring and conduit. Ownership of said removed fixtures shall be retained by Grantee(s). Said easement, as shown on said **Exhibit "A"**, shall be relinquished to Grantor(s) by Grantee(s) upon recordation of this agreement in Skagit County Auditors office and said easement shall be restored to its original condition by Grantee(s).

Grantor(s) and Grantee(s) agree to adhere to all other agreed upon terms and conditions of Said Restrictive Covenant And Well Agreement and said agreement shall remain in force. As stated in said Restrictive Covenant And Well Agreement Grantor(s) and Grantee(s) agree to enter into a future agreement to create a public water system to serve Grantor(s) and Grantee(s) future domestic water needs from an existing well described in said Restrictive Covenant And Well Agreement. Grantor(s) and Grantee(s) acknowledge said public water system shall be a public Group B System and shall comply with all applicable municipal codes and laws. As stated in said Covenant And Well Agreement Grantor(s) shall agree to participate and cooperate in the execution of any and all necessary documentation, allowing Grantee(s) to proceed with application for approval of said public Group B Water System at a future date.

All parties agree this agreement, herein, shall run with the land and shall be binding to all parties hereto, their heirs, successors or assigns and all subsequent owners thereof. This agreement and said **Restrictive Covenant And Well Agreement** shall survive any previous verbal discussions or agreements.


