- That a Principal reduction of Ninety Thousand Dollars & No/100 (\$90,000.00) 2 will be applied on July 19, 2007, bringing the total principal balance to: One Hundred Thirty Five Thousand Dollars & No/100 (\$135,000.00)
- Payments shall decrease to \$1.068.75. 3
- That all of the terms and conditions of the Note and Deed of Trust shall continue 4 except as herein modified.
