That portion of Government Lot 1 of Section 1, Township 33 North, Range 4 East, W.M., described as follows:

Begin at a point on the North line of said Government Lot 1 which lies North 88 degrees 10' 06" West, a distance of 496.20 feet from the Northeast corner thereof; thence South 52 degrees 52' 30" West, a distance of 74.83 feet to the centerline of the railroad right-of-way commonly known as the Northern Pacific Railway (originally conveyed to the Seattle, Lake Shore and Eastern Railway) which point is on a curve concave to the Northeast and from which the radius point bears North 52 degrees 52 30" East, a distance of 2,864.93 feet; thence Northwesterly along said curve through a central angle of 1 degree 12' 00", an arc distance of 60.00 feet to a point on the North line of said Government Lot 1; thence South 88 degrees 10' 06" East along said North line, a distance of 95.42 feet to the Point of Beginning.
