THIS TERMINATION OF LEASE (this "Termination) is made as of the 21 day of

August, 2007 by and between David B. Tjersland (Lessor) and Hulbert Farms, Inc.

(Lessee).

RECITALS

- A. Lessor and Lessee are parties to that certain Farm Lease dated as of March 12, 2004 for farmland legally described above.
- B. Lessor, as seller, and Bryan Todd Lenning, as purchaser (the "Purchaser"), are parties to that certain Agreement of Purchase and Sale, dated as of July 30, 2007, whereby the Purchaser shall acquire the real property described in the Purchase Agreement and upon which the Premises (as defined in the Lease) are situated.
- C. The sale of this farmland is intended to close on or about August 22, 2007.
- D. Lessor and Lessee now desire to terminate the Lease on the terms and conditions set forth in this Termination.

AGREEMENT

- 1. Termination Date. The Lease shall terminate upon the consummation of the sale of the Premises contemplated by the Purchase Agreement (the Termination Date) which such closing is anticipated to occur on or about August 22, 2007. If, for any reason, the transaction contemplated by the Purchase Agreement is not consummated and the real property is not transferred to the Purchaser, the Lease shall continue on in full force and effect.
- 2. Payment of Rent. Lessee shall pay Lessor rent due for the period from March 31, 2007 to August 15, 2007 (\$2969.76) on or before September 30, 2007.
