- 1. In the event any portion of the property is taken or damaged in an eminent domain proceeding, the entire amount of the property is taken or damaged in an eminent domain proceeding, the entire amount of the award or such portion as may be necessary to fully satisfy the obligation secured hereby, shall be paid to Beneficiary to be applied to said obligation.
