The undersigned subordinator and owner agree as follows:

- Na Ju Corporation referred to herein as "owner," is the owner of all 3. the real property described in the mortgage identified above in Paragraph 2.
- In consideration of benefits to "subordination" from "owner," receipt and 4. sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its mortgage and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of his mortgage identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above, and all advances or changes made or accruing thereunder, including any extension or renewal thereof.
