### AMENDMENT TO EASEMENT

This Amendment to Easement is by and between MILES SAND & GRAVEL CO., INC., a corporation, hereinafter referred to as "Miles," and DANIEL D. RASAR and ANN J. RASAR, husband and wife, and JOHN KEVIN RASAR and CHERYL A. RASAR, husband and wife, collectively referred to as "Rasar" to provide for the amendment and modification of that Easement Agreement recorded under Skagit County Auditor's File No. 489927, Volume 256, page 687-91. Said Easement Agreement is made part of this Amendment Agreement. Miles agrees to limit and restrict the use of the "Private Roadway" as described in the said Easement Agreement over and across the Rasar

property to limit the easement to access for government emergency vehicles and providing emergency access for people using cars and pickups, all only when other vehicular routes are not useable or available. This modification to limit and restrict the use of the "Private Roadway" shall be in effect when site development for mining and mining accessory uses begins at the Belleville pit. At such time as the mining and mining accessory uses permitted at the Belleville pit shall cease and the Belleville pit is no longer used for sand and gravel extraction or accessory mining uses, this limitation and restriction on the use of the "Private Roadway" shall cease. Miles further agrees to limit and restrict the use of the "Private Roadway" thereafter to serve only non-commercial and non-industrial uses at the Belleville site. This Amendment and Modification to Easement Agreement is binding on the parties hereto and their heirs and assigns.

The parties have signed this Agreement this 3<sup>rd</sup> day of January, 2003.

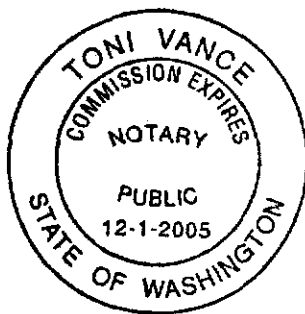

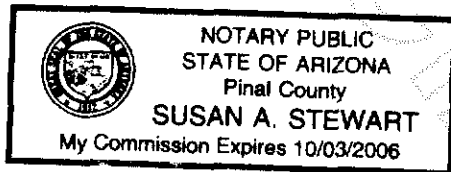
