THE GRANTOR, REGIONAL TRUSTEE SERVICES CORPORATION, as present Trustee under that Deed of Trust, as hereinafter particularly described, in consideration of the premises and payment, recited below, hereby grants and conveys without warranty, to: U.S. Bank National Association as Trustee under Pooling and Servicing agreement dated as of March 1, 2006 Asset Backed Securities Corporation Home Equity Loan Trust, Series NC 2006-HE2 Asset Backed Pass-Through Certificates, Series NC 2006-HE2, GRANTEE, that real property, situated in the County of SKAGIT, State of WASHINGTON, described as follows:

- 1. This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust dated 12/7/2005, recorded in Auditor's/Recorder's No. 200512160141, records of SKAGIT County, Washington, from MICHAEL DAVIS AND MARY-GRACE WALLACE, AS JOINT TENANTS, as Grantor, to CHICAGO TITLE, as Trustee, in favor of NEW CENTURY MORTGAGE CORPORATION, as Beneficiary.
- Said Deed of Trust was executed to secure, together with other undertakings, the payment of a
 promissory note in the sum of \$167,670.00, with interest thereon, according to the terms thereof, in
 favor of NEW CENTURY MORTGAGE CORPORATION and to secure any other sums of money
