## Final Order to Vacate

The Board, having on the 20th day of August, 2007, ordered the vacation of said right-of-way upon payment by the principal petitioner of all costs and expenses incurred in the proceedings, with said costs and expenses amounting to the sum of \$183.00 having been paid to the Treasurer's Office of this county:

It is ordered by the Board, all the member concurring, that the County right-of-way requested to be vacated by the Upper Skagit Indian Tribe, be vacated described as follows:

**That portion of Darrk Lane (Old Bow Hill Road, Warner Road, County Road #50010) bound on the west by the easterly margin of Interstate 5 and on the south by a line offset 90.00 feet northerly of and parallel with the centerline of Bow Hill Road (County Road #21200), being described as follows:**

Commencing at a monument marking the north one-quarter corner of Section 06, Township 35 North, Range 04 East, W.M., thence along the north-south center of section line south  $03^{\circ}10'32''$  west 443.15 feet to the northeasterly margin of said Darrk Lane and the point of beginning; thence along said margin north  $52^{\circ}52'21''$  west 305.79 feet to a point of curvature from which the radius bears south  $37^{\circ}07'39''$  west 746.52 feet; thence northwesterly along said curve through a central angle of  $36^{\circ}48'07''$  a distance of 479.50 feet to the easterly margin of Interstate 5; thence along said easterly margin south  $10^{\circ}16'43''$  east 61.14 feet to the south margin of said Darrk Lane, being a point on a curve from which the radius bears south  $01^{\circ}15'52''$  west a distance of 686.52 feet; thence southeasterly along said curve through a central angle of  $35^{\circ}51'47''$  a distance of 429.71 feet to a point of tangency; thence south  $52^{\circ}52'21''$  east 656.82 feet to a point of curvature from which the radius bears south  $37^{\circ}07'39''$  west a distance of 60.00 feet; thence southerly along said curve through a central angle of  $68^{\circ}46'44''$  a distance of 72.03 feet to a point of tangency; thence south  $15^{\circ}54'23''$  west 19.82 feet to a point on a curve on said 90.00 foot offset line, and from which the radius bears north  $01^{\circ}12'52''$  east a distance 1055.69 feet; thence easterly along said curve through a central angle  $9^{\circ}42'54''$  a distance of 179.00 feet to said northeasterly margin of Darrk Lane north  $52^{\circ}52'21''$  west 549.53 feet to the point of beginning.
