NOTICE OF DEFAULT AND FORECLOSURE SALE

WHEREAS, on 02/23/2005, a certain (Deed of Trust) was executed by ROBERT H. BENSON, as Trustor in favor of WELLS FARGO BANK, N.A., as beneficiary and H AND L SERVICES, INC, as Trustee and was recorded on 02/28/2005, as INSTRUMENT NO 200502280262 the office of the SKAGIT County, WASHINGTON Recorder, and

WHEREAS, the Deed of Trust was insured by the UNITED STATES SECRETARY OF HOUSING AND URBAN DEVELOPMENT, (the Secretary) pursuant to the National Housing Act for the purpose of providing single family housing, and

WHEREAS, the beneficial interest in the Deed of Trust is now owned by the Secretary, pursuant to an assignment recorded on 01/02/2007, as INST# 200701020059 in the office of the SKAGIT County, WASHINGTON, Recorder, and

WHEREAS, a default has been made by reason of failure to pay all sums due under the Deed of Trust, pursuant to Paragraph 9 Subsection (i) of said Deed of Trust and

WHEREAS, by virtue of this default, the Secretary has declared the entire amount of the indebtedness secured by the Deed of Trust to be immediately due and payable,

NOW THEREFORE, pursuant to powers vested in me by the Single Family Mortgage Foreclosure Act of 1994, 12 U.S.C. 3751 et seq., by 24 CFR part 27, subpart B, and by the Secretary's designation of us as "Foreclosure Commissioner" notice is hereby given that on 01/11/2008 at 10:00 AM local time, all real and personal property at or used in connection with following described premises ("Property") will be sold at public auction to the highest bidder:

More thoroughly described as: THAT PORTION OF THE NORTHWEST 1/4 OF THE NORTHWEST 1/4 OF SECTION 9, TOWNSHIP 33 NORTH, RANGE 4 EAST, W.M., AND MORE PARTICULARLY DESCRIBED IN SAID DEED OF TRUST.

The sale will be held at the following location:

AT THE COUNTY COURTHOUSE, 205 W. KINCAID, MOUNT VERNON, WASHINGTON

Per The Secretary of Housing and Urban Development the estimated opening bid will be \$198,560.16.

There will be no pro-ration of taxes, rents or other income or liabilities, except that the purchaser will pay, at or before the closing, his prorata share of any real estate taxes that have been paid by the Secretary to the date of the foreclosure sale.

When making a bid, all bidders except the Secretary must submit a deposit totaling ten percent (10%) of the Secretary's estimated bid amount, in the form of cashier's check made payable to the Foreclosure Commissioner. Each oral bid need not be accompanied by a deposit. If the successful bid is an oral, a deposit of \$19,856.16 must be presented before the bidding is closed. The deposit is nonrefundable. The remainder of the purchase price must be delivered within 30 days of the sale or at such time as the Secretary may determine for good cause shown, time being of the essence. This amount, like the bid deposits, must be delivered in the form of a cashier's or certified check. If the Secretary is the high bidder, he need not pay the bid amount in cash. The successful bidder will pay all conveyancing fees, all real estate and other taxes that are due on or after the delivery of the remainder of the payment and all other costs associated with the transfer of title. At the conclusion of the sale, the deposits of the unsuccessful bidders will be returned to them.

The Secretary may grant an extension of time with which to deliver the remainder of the payment. All extensions will be for 9-day increments for a fee of \$250.00 paid in advance. The extension fee shall be in the form of certified or cashier's check made payable to the Commissioner. If the high bidder closes the sale prior to the expiration period, the unused portion of the extension fee shall be applied toward the amount due.

If the high bidder is unable to close the sale within the required period, or within any extensions of time granted by the Secretary, the high bidder may be required to forfeit the cash deposit or, at the election of the Foreclosure Commissioner after consultation with the HUD Field Office representative, will be liable to HUD for any costs incurred as a result of such failure. The Commissioner may, at the direction of the HUD Field Office Representative, offer the property to the second highest bidder to an amount equal to the highest price offered by that bidder.

There is no right of redemption, or right of possession based upon a right of redemption, in the mortgagor or others subsequent to a foreclosure completed pursuant to the Act. Therefore, the Foreclosure Commissioner will issue a Deed to the purchasor(s) upon receipt of the entire purchase price in accordance with the terms of the sale as provided herein. HUD does not guarantee that the property will be vacant.

The amount that must be paid by the Mortgagor, to stop the sale prior to the scheduled sale date is \$198,560.16 as of 01/10/2008, PLUS all other amounts that are due under the mortgage agreement.

Plus advertising costs and postage expenses incurred in giving notice, mileage by the most reasonable road distance for posting notices and for the Foreclosure Commissioner's attendance at the sale, reasonable and customary costs incurred for title and lien record searches, the necessary out-of-pocket costs incurred by the Foreclosure Commissioner for recording documents. Plus a commission for the Foreclosure Commissioner and all other costs incurred in connection with the foreclosure prior to reinstatement.
