THIS AGREEMENT (the "Agreement") is made the date set forth below, by and between JOHN J. PIAZZA a/k/a JOHN J. PIAZZA, SR. and DOROTHY ANN PIAZZA, husband and wife, (hereinafter "Grantors") and SAVE ON STORAGE, LLC, a Washington limited liability company (hereinafter as "Grantee"), who hereby agree as follows:

1) JOHN J. PIAZZA and DOROTHY ANN PIAZZA, husband and wife, are the owners of the following described parcel of property in Skagit County, Washington (hereinafter "Grantors' Parcel"):

Section 18, Township 34 North, Range 4 East, W.M., located in the County of Skagit, State of Washington.

2) SAVE ON STORAGE, LLC, a Washington limited liability company, is the owner of the following described parcels of property in Skagit County, Washington: (hereinafter "Grantee's Parcels")

Those certain parcels of land listed and described on Exhibit "A" attached hereto and incorporated by reference as if fully set forth herein.

Situate in the County of Skagit, State of Washington.

3) EASEMENT: The easement conveyed herein is more particularly described as follows:

A non-exclusive, perpetual easement for ingress and egress over and across the South thirty (30) feet (as measured perpendicular to the South line) of Tract 1 of Binding Site Plan No. MV 1-91, approved April 18, 1991 and recorded April 19, 1991 under Auditor's File No. 9104190001 in Volume 1 of Short Plats, page 350, records of Skagit County, Washington, being a portion of the Northeast ¼ of the Northeast ¼ of Section 18, Township 34 North, Range 4 East, W.M., located in Skagit County, Washington.

SUBJECT TO: Easements, restrictions and reservations of record. Situate in Skagit County, Washington.

NOW, THEREFORE, in consideration of the mutual promises and covenants herein, the receipt and sufficiency of which consideration is hereby acknowledged, the parties agree as follows:

- 1) Grantors hereby grant and convey to Grantee the easement, over and across Grantors' Parcel, which easement is more particularly described above.
- 2) The easement shall be non-exclusive and shall remain in effect in perpetuity, until terminated by the mutual written and recorded agreement of the owners, or by the operation of law.
- 3) This easement is to be held by Grantee, their heirs and successors and assigns as appurtenant to Grantee's Parcel. The benefits, burdens and covenants of this easement and this Agreement shall be deemed to run with the land and bind the owners of Grantee's Parcel and

Grantors' Parcel, and their respective heirs, successors, and assigns and all persons possessing the property by, through and under the parties hereto and their respective heirs, successors and assigns.

- 4) This easement shall not effect a merger of the fee ownership and the easement. The fee and easement shall hereafter remain separate and distinct.
- 5) Grantor and Grantee shall each name the other as an additional insured on any policy of general commercial liability insurance maintained by the Grantor or Grantee.


