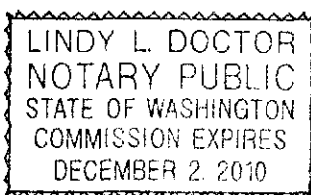

DESCRIPTION:

PARCEL "A":

Lots 1 and 2, the East 25 feet of Lots 15, 16 and 17, and that portion of Lots 18, 19 and 20, Block 135, "MAP OF THE CITY OF ANACORTES, SKAGIT COUNTY, WASHINGTON," as per plat recorded in Volume 2 of Plats, page 4, records of Skagit County, Washington, lying Northerly of the North line of the former Burlington Northern Railway Company right-of-way as originally located and constructed.

TOGETHER WITH that portion of the vacated alley adjacent thereto that would attach to said premises by operation of law.

Situate in the City of Anacortes, County of Skagit, State of Washington.
