Drainage Easement

THIS INSTRUMENT, entered into by the Grantor to provide an easement for access, construction and maintenance of a buried drainage pipeline for the benefit of the Grantee.

THEREFORE, Dennis W Maxfield and Gwenn L Maxfield, Grantors, hereby grant to Arvid O Mostad and Shirlee D. Christensen, Grantees, and benefiting Skagit County Auditor's parcel No. P-73538, an eight foot wide drainage easement on the following described property:

That portion of the Maxfield property, Skagit County Assessor Parcel No P-73511, across and under the West ½ of vacated Island Street and that portion of the tract known as Millers Reserve lying South of Gibralter Road as shown on the Plat of the Townsite of Gibralter, as per plat recorded in Volume 1 of Plats, page 19, records of Skagit County, Washington and defined under Skagit County Auditors file No 200007240080, and being more specifically described as follows:

Commencing at the intersection of the centerline of said vacated Island Street with the Southerly right-of-way margin of Gibralter Road as shown on that certain Record of Survey map recorded under Skagit County Auditors file No 200101230028; thence South 25°31'52" East along said centerline for a distance of 31.5 feet, more or less, to the TRUE POINT OF BEGINNING of said easement;

thence South 81°28'08" West for a distance of 42.0;

thence North 8°31'52" West for a distance of 8.0 feet;

thence North 81°28'08" East for a distance of 39.6 feet, more or less;

thence South 25°31'52" East for a distance of 8.4 feet more or less, to the TRUE POINT OF BEGINNING.

The disturbed ground must be restored to its original condition after any installation, maintenance or repair. Maintenance cost of said drainage pipeline shall be born by the Grantee. Grantee shall have access to the easement area for normal maintenance activities to the drainage pipeline.

Subject to and together with easements, reservations, restrictions, covenants, liens, leases, court causes and other instruments of record.

These covenants shall run with the land and are binding upon all subsequent owners.
