## Declaration of Easement Protecting Reserve Drainfield

Kristin A. The residence's reserve drainfield is located in the southeast corner of 5072 Guemes Island Road as designated on the site plan attached to this declaration.

Under the terms of this easement, owner declares that the area encompassing the reserve drainfield shall be protected by a fence to prevent vehicular intrusion and maintained consistent with a natural vegetative state. Owner further declares that no chemicals, including, but not limited to, pest control and fertilizer products, shall be used in this area, nor shall the dumping of oil or other chemicals be allowed in this area.

Owner agrees to undertake the protection of the reserve drainfield in accordance with the above declaration. This easement shall be binding upon the Owner, its successors and assigns and shall run with the above-described properties.
