The undersigned Subordinator and Owner agrees as follows:

- Skagit State Bank, referred to herein as "Subordinator," is the owner and holder of a mortgage/deed of trust dated July 13, 2007 which is recorded under Auditor's file No. 200707270090 Records of Skagit County.
- , referred to herein as "Lender" is the owner and holder of a Skagit State Bank , executed by Robert and Nadine Springer under mortgage/deed of trust dated March 2008 Auditor's File No. 2008 0310 02000 , Records of Skagit County (which is to be recorded concurrently herewith). 199
