The Declarant hereby establishes that the owner, subsequent owners, heirs, executors, assigns or successors of Lots 1, 2, and 3 as described herein shall be bound by the terms of easement and maintenance and all parties agree that:

- 1. The owners of Lots 1, 2, and 3 share in a pro-rata cost of agreed maintenance and/or improvements of that portion of the driveway that provides access to Lots 1, 2, and 3. The cost of maintenance and improvements are the responsibility of the owners of lots 1, 2, and 3 for that portion of the driveway that provides access to only lots 1, 2, and 3 herein.
- 2. It is understood that the repair and maintenance for said Driveway is for the benefit of all three property owners.

The easement and agreement contained herein shall be binding upon the parties herein and their successors and assigns, and shall be construed as covenants running with the land.
