LOAN MODIFICATION AGREEMENT

THIS AGREEMENT is made on April 11, 2008, between <u>Timothy J Lord and Marilyn K Lord</u>* (individually and collectively, if more than one, "Borrower") and WASHINGTON MUTUAL BANK, FA (The "Bank")

* Trustees of the Tim and Marilyn Lord Living Trust, dated August 5, 1999.

Borrower has obtained a loan from the Bank (the "Loan") in the original credit limit amount of <u>One Hundred Nine Thousand Dollars and 00/100 (\$109,000.00)</u>. Borrower and the Bank now wish to make certain modifications to the loan terms, and in consideration of the mutual benefits accruing to each, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. Modification to Agreement. The Agreement is hereby modified as follows:
 - 1.1 Credit Limit. The maximum credit limit shall be lowered to \$50,000.00 from \$109,000.00.
- 2. Miscellaneous. Except as herein modified, all the terms, covenants and conditions of the Agreement and Deed of Trust remain in full force and effect without modification or change. Each of the undersigned borrowers hereby ratifies and reaffirms such Borrower's personal liability for the payment of obligations contained in the Agreement and Deed of Trust. Nothing herein shall affect the validity or lien priority of the Deed of Trust on the property as security for the payment of all amounts owing on the Agreement as herein modified.
