- 1. The real estate is necessary for a public use of the City of Mount Vernon.

If it becomes necessary for the City to institute condemnation proceedings, the Owner has no objection to the State entering an Order Adjudicating Public Use, as provided by RCW 8.08.040, and agrees that this instrument shall be treated as having the same legal effect as an Order for Immediate Possession provided by RCW 8.04.090, et seq., which, by this reference, are incorporated herein as if fully set forth.
- 5. The date of valuation for the determination of just compensation shall be the date that this agreement is accepted and approved by the City of Mount


