The determination for a Lot of Record is based on a review of the conveyance documents submitted, including, but not necessarily limited to: the legal description contained in each conveyance document; assessing when parcels came together; when parcels were separated; and what County regulations, if any, were in effect at the time of conveyance of any specific legal description.

This office has completed review of the Lot Certification Applications and based on information submitted the following determinations have been made:

Lot of Record Certification PL08-0203:

Lot Certification PL08-0203 is comprised of the legal descriptions associated with the West 1/2 of Government Lot 2, Parcel P17896 and the West 1/2 of the Southwest 1/4 of the Northeast 1/4, which is the West 1/2 of Parcel P17903 and P17897, a 60 ft. strip of land that had been designated for use as a road, as a total unit. This legal description was established under AF 389107, March 6, 1946.

The subject property as a total unit is considered to be approximately 40 acres in size, based on subdivisional descriptions. There is currently one existing residence and a variety of accessory structures located on the subject property. The current zoning is Rural Resource-Natural Resource Land with a Mineral Resource Overlay. The subject property is in compliance with the required minimum lot size.
