THIS AGREEMENT is made and entered into this 03/17/2008, by and between Citibank, N.A., whose place of business is 3900 Paradise Road, Suite 127, Las Vegas, NV 89109 (the "Lender"), and MICHAEL A MCKINLAY and GERALYN M MCKINLAY, HUSBAND AND WIFE (collectively referred to herein as "Borrower"). The "Property" means the real estate located at 1308 GILKEY RD E, BURLINGTON, WA 98233-<u>000</u>0.

WHEREAS, Borrower obtained a home equity line of credit from Lender, on 04/03/07, which line of credit is evidenced by a Home Equity Line of Credit Agreement and Disclosure (referred to herein as the "Note") and secured by a Security Instrument ("Security Instrument") in the form of a mortgage or deed of trust recorded as 200704030053 of the Official Records of SKAGIT county (or if secured by a co-op, a security interest in the stock ownership of the co-op). WHEREAS, Borrower has requested that the Credit Limit set forth in the Note be increased, and Lender is willing to allow the Credit Limit to be so increased.

NOW, THEREFORE, in consideration of the mutual promises contained herein, Lender and Borrower agree as follows:

CREDIT LIMIT INCREASE. Borrower and Lender hereby agree to increase the Credit Limit set forth in 1. the Note to \$130,400.00 and to modify the Security Instrument so that the principal amount secured by the Security Instrument is \$130,400.00.

- COMPLETE TRANSACTION. Except as expressly modified by this Agreement, all terms of the Note 4. and Security Instrument remain in full force and effect. By signing below, Lender and Borrower acknowledge there are no additional terms or agreements between them, oral or written.
- NON-WAIVER. This Agreement does not constitute a limitation or waiver of Lender's rights to prohibit, 5. or restrict, any future modifications requested by Borrower or to enforce any rights or remedies contained in the Note or Security Instrument.
- OTHER TERMS. If any terms of this Agreement are deemed invalid or unenforceable, or otherwise 6. affect a lien priority of the Security Instrument, this Agreement shall immediately terminate and the original terms of the Note and Security Instrument shall apply.
