
All that portion of the following described PARCEL "A" lying within a tract of land beginning at a point opposite Highway Engineer's Station (hereinafter referred to as HES) 117+55 on the SR 9 line survey of SR 9, Prairie Road to Thunder Creek Vic. and 50.00 feet southwesterly therefrom; thence southwesterly to a point opposite HES 117+40 on said line survey and 130 feet southwesterly therefrom; thence northerly parallel with said line survey to a point opposite HES 118+00 thereon; thence northeasterly to a point opposite said HES 118+00 and 50.00 feet southwesterly therefrom; thence southeasterly parallel with said line survey to the point of beginning.
